If you need to discuss the cost of individual trips, once the letters have been sent out, then please come and speak with me. Contributions to trips are voluntary, however if insufficient contributions are made, then trips may need to be cancelled.

We want to support our families in any way that we can and so if your circumstances have changed, or perhaps you haven't done it previously, and you would like to check if your child qualifies for free school meals, please contact our school office who will provide you with the relevant paperwork or you can do this via the Bradford Council website:

You can apply for school meals if you receive:

- Income Support
- Income Based Jobseekers Allowance
- Income Related Employment and Support Allowance
- Child Tax Credit with an annual income of less than £16,190, provided they are not receiving Working Tax Credit
- the 'Guaranteed' element of the State Pension Credit
- Working Tax Credit run-on (paid for 4 weeks after you stop qualifying for Working Tax Credit)
- Universal Credit with an annual net earned income threshold of less than £7,400.
